MEMORANDUM OF UNDERSTANDING

Purpose

The purpose of this Memorandum of Understanding (MOU) between K.S. INSTITUTE OF TECHNOLOGYS and M/S LIVEWIRE is to initiate a formal relationship under which future cooperation on joint research and project initiatives will be facilitated.

The different business process and different parties that are incubated in the centre require a simple and formal approval from the centre, again that to take care of the challenges which may come across in due course. It is preferred to have a rudimentary ISO 9000 process documentation to the final stages of product development in case if it happens to be a physical products development. It may be preferred, that the Information Technology entrepreneurs comply with the CMM level 3 though not mandatory.
 3. **Facility-Based Services** - Incubator to provide office space for businesses. Incubators offer flexible leases, shared use of conference rooms, reception, and other common areas. Incubators provide emerging businesses with an infrastructure of local area network and Internet services along with shared use of basic amenities to run the Business smoothly. An incubator can give a new company a much-needed visible identity to help promote its offerings and find funding or investment capital.
 4. **Intern Network** KSIT to provide a talented, affordable work pool as interns for special projects on an ad hoc or ongoing basis, on areas of particular use, but are not limited to, graduate level technology. KSIT should identify internship directors and establish a process that provides learning and development to the interns.

5. **Non Disclosure Agreement by Interns:** Interns has to sign a Non - disclosure agreement with M/S LIVEWIRE Agreement contents will be shared with KSIT along with this MOU as Annexure.
6. **Disputes:** If any dispute or difference cannot be resolved between the Parties by active, open and good faith discussion, the Parties will enter into mediation. However, this Memorandum of Understanding (MoU) may be terminated immediately by either party should this Memorandum be seriously breached by giving at least 3 months notice.
7. **Review:** The Parties will meet to review the operation of this MoU six months after signing, and at least annually after that.
8. **Amendment:** This MoU may be amended at any time by agreement in writing (including email) between the Parties.

Partnership Values

The Parties agree to:

- Work as a team (“the Team”).
- Support each other in finding the most efficient ways to deliver the Project requirements.
- Be open, frank, honest and constructive in all dealings with each other.
- Share work equitably and reasonably, consistent with agreed arrangements.
- Use this MoU as a benchmark against which each Party, and the Team as a whole, can set its approach to potential issues of conflict between them as work progresses.

Term

This MoU commences on the date signed by both Parties and will continue at least for three years until terminated by either of the Parties. The terminating party will give as much notice as possible. The Parties will seek ways to maintain the information and services available to the community after the termination of this Memorandum of Understanding.
