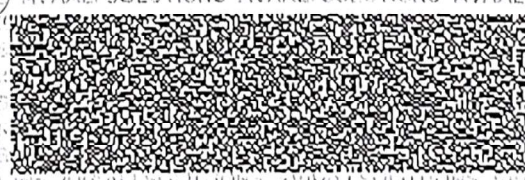

This Memorandum of Understanding ("MOU") is entered into at effective as of 24.02.2022, by and between:

Avaali Solutions Private Ltd, a company incorporated under the provisions of the Companies Act, 1956 and having its registered office at 1st Floor, SV Towers, #27, 80 Feet Road, 6th Block, Koramangala, Bangalore - 560095 and hereinafter unless the context otherwise requires be referred to as "Avaali".

And

K S Institute of Technology, having its registered office and campus at 14, Raghuvanahalli, Kanakapura Main Road, Bengaluru- 560109 hereinafter unless the context otherwise requires be referred to as "K S I T".

WHEREAS K S I T and Avaali having felt the need to provide the learners with the trainings which may lead to enhanced skills, Avaali and K S I T agree to collaborate through the Avaali Academic Initiative Program.

WHEREAS K S I T and Avaali agree that all discussions between K S I T and Avaali are non binding unless and until the parties enter into written, definitive agreement signed by their duly authorized representative and neither party shall be obligated to enter into such an agreement.

Now therefore this MOU witnesses:

#### 1- DEFINITIONS

K S I T, shall include, unless repugnant to the context otherwise require, its associates-

"Faculty" hereby refers to Training Staff of K S I T

"Students" hereby refers to all the students of K S I T

"Program(s)" hereby refers collectively to Avaali Academic Initiative Program that includes initiatives like Process Mining, VIM Solution Management, Vendor Portal Management, Business Process Automation etc. for Engineering, IT & MCA students of colleges and Universities.

Academic Initiative Course as agreed with K S I T for which K S I T students or faculty members will receive training

Software" or "Product" means the Avaali computer software packages identified for introduction in the Program

Courseware" hereby refers to books or education material given in any form like soft copies like PDFs etc.

## **Perceived benefits of the collaboration**

### **a) K S I T**

- Opportunity to emerge as one of the competent entities in the academic circles in various areas of Information technology;
- Opportunity to be recognized by the Industry and academic circles as one of the preferred location/institution for acquiring training and skills in latest technology and software;
- Opportunity to students and faculty members to increase their knowledge and acquire skills on best-in-class automation Software
- Opportunity to learn from the practitioners in the industry
- Opportunity to setup a joint and co-branded Lab on the campus with Avaali, focused on various specialty areas like Business Process Automation, process mining etc
- Opportunity to conduct independent non-commercial research by faculty members as per guidelines from Avaali time to time
- Opportunity to conduct various seminar and workshops with Avaali in the institution

### **b) Avaali**

- Availability of skilled resource pool armed with Automation Software skills that Avaali may want to evaluate for recruitment
- Propagation of Automation Software and technology knowledge & skill to various students and faculty members

## **3- TERMS AND CONDITIONS**

### **a) Courseware and Training**

Avaali, through its own personnel or authorized business partners, will provide Courseware and/or perform the Training activities for Academic Initiative courses as per the details given below in Annexures. The MoU shall only govern the provision of products and services provided by Avaali.

Under this MOU, K S I T also assures Avaali that it will enrol its students and/or faculty members taking Avaali Academic Initiative courses every year from the effective date of the signing this MoU provided that K S I T

Students qualify for enrolment based on passing assessment tests that Avaali will conduct. It will also be the endeavour of the K S I T management to initiate the process of Avaali Academic Initiative courses to be included in their curriculum in case it has not been included so far.

#### **b) Software & Hardware**

The application on which trainings shall be conducted will be provided by Avaali and shall be the responsibility of Avaali subject to K S I T provides the requisites Hardware and OS required to run these applications. The requisite Hardware and Operating System Details are listed in Annexure A below.

Any other related software requirements as well as incremental hardware requirements, as listed in Annexure A shall remain the responsibility of K S I T

#### **4 - BREACH OF MOU**

In the event of any breach of the terms of this MOU, which is capable of rectification, by either party hereto, such other party shall be entitled to call upon the party to rectify such breach within fifteen days from the date of the notice, failing which the breach shall be deemed to be a material breach, and shall entitle such other party to rescind this MOU for material breach.

#### **5 – TERM AND TERMINATION**

The MOU shall be effective from the effective date, and shall be valid for a term of two (2) years, unless terminated earlier by either party, or extended mutually by both parties hereto, on the same terms and conditions as herein.

This MOU will terminate upon written notice by either party. The notice of termination should be issued at least 30 days before the intended date of termination unless extended or terminated earlier. If at any time any party wishes to withdraw from further evaluations and discussions in connection with the subject matter of this MOU and terminate this MOU, it may do so with or without cause and without liability by providing the other party with written notice of its intention to withdraw from further evaluations and discussions. (in case Avaali is providing training then Avaali to complete the batch in session irrespective of termination period / date, subject to all the payments and other obligations having been met by K S I T in a timely manner).

In the event of termination of this MOU for any reason whatsoever, including termination due to breach by Avaali, any software or courseware licenses granted to K S I T by virtue of this MOU, shall also stand automatically terminated without any further act of parties. K S I T will also return or destroy at Avaali's discretion, all material provided by Avaali including courseware slides, soft copy courseware provided by Avaali towards trainings.

The following obligations will survive termination of this MOU for any reason:

Use and nondisclosure of confidential information,

...mnification and Liability,

obligations to make payments of amounts by K S I T that become due by virtue of this MOU, prior to termination.

## 6 – LIMITATION OF LIABILITY

Neither party shall be liable for any indirect, punitive, special, incidental or consequential damages arising out of or in connection with this MOU, whether for breach of this MOU or in torts, including loss of business, data, revenue, profits, or for any third-party claims against the other.

## 7 – ARBITRATION

Any and all disputes, controversy or claims related to or arising in connection with this MOU shall first be referred to the Head of K S I T and Business Development Head, Academic Initiative for an informal resolution.

If this informal resolution does not resolve the dispute, then the matter will be referred to and settled by binding arbitration in accordance with the Arbitration and Conciliation Act, 1996. The status of any such arbitration shall be Bengaluru. The award of the arbitration may be enforceable in any court of competent jurisdiction. Each party shall bear its own costs and fees in connection with the arbitration.

If one of the parties refuses or otherwise fails to appoint an arbitrator within 30 days of the date the other party appoints, the first appointed arbitrator shall be the sole arbitrator, provided that the arbitrator was validly and properly appointed. All proceedings shall be conducted, including all documents presented in such proceedings, in the English language. The English language version of this Agreement prevails over any other language version.

## 8– GENERAL

This MOU shall not be construed to be an agency or a partnership or joint venture or an employment relationship. Neither party shall be entitled to bind the other party with any third party by its actions, unless it has specifically obtained the prior written consent of such other party to do so.

Each party is an independent contractor, and nothing under this MOU shall be construed to create an employment relationship, whether for tax or for any other purpose, nor any partnership or joint venture between the parties. No provision of this MOU grants either party any express or implied right of authority to assume or create any obligations or responsibility on behalf of or in the name of the other party, or bind the other party in any manner or thing whatsoever. Neither party nor its personnel shall be considered employees of the other.

Neither party shall assign or transfer this MOU or any benefits or rights or obligations accruing to it under this MOU, without the prior written consent of the other party.

Avaali shall during the term of this MOU be entitled to audit the courseware & the software license usage records of licenses hosted on K S I T premises as well as training attendance records maintained by K S I T. This audit can be conducted only during reasonable business hours and two weeks notice for audit. Cost of the audit is to be borne by Avaali.

The existence and substance of this MOU and the rights and obligations of the parties herein will be kept confidential by K S I T and will not be disclosed to any third party without the prior written consent of Avaali. Notwithstanding the foregoing, K S I T may make such disclosure to the extent required by law, court or statutory authority, in which case K S I T will promptly inform Avaali to allow Avaali a reasonable opportunity to obtain a protective order. Avaali and K S I T agree not to use the trademark, trade names, services or any other proprietary marks of the other party in any advertisement, press releases, publicity matters or other promotional materials without prior written approval of the other party. Provided that both parties agree to issue any press release, publicity or media interaction pertaining to this MoU signing or Avaali activities on campus which could be issued based on prior approval of the content from both parties. The use of Avaali Logo shall be subject to prior written permission by Avaali and under the terms of the applicable agreement such as Trade Mark License Agreement executed between K S I T and Avaali or Avaali's parent or affiliates. Any violation of this paragraph will amount to material breach and will lead to the termination of this MoU.

This MOU supersedes all prior oral or written communication, discussions and representations communicated between the parties hereto in respect of the subject matter of this MOU. Any modification to this MOU shall only be made by way of a written document duly executed by representatives of both parties hereto.

If any provision of this MOU is held to be unenforceable or illegal under certain circumstances for any reason, such decision shall not affect the validity or enforceability of such provisions under other circumstances or the remaining provisions hereof and such provisions shall be reformed only to the extent necessary to make them enforceable under such circumstances.

Any notice under this MOU will be in writing and delivered by hand or by registered mail, return receipt requested, to the other party at the registered office or as may be substituted by the notice. If any notice is sent by mail, notice will be effective on the date of receipt.

K S I T shall maintain at all times, a one-point contact for the Avaali trainings being conducted at the institution. Any change in the contacts below will be promptly notified to Avaali.





**Memorandum of Understanding  
Between

for  
Collaborative R&D in the area of Personal Health and Wellbeing**

**1. Purpose, Objectives and Goals:**

- 1.1. Purpose:** This Memorandum of Understanding (MoU) which establishes the framework for collaborative Research and Development in the area of Health IoT (hereafter called "Collaboration") entered on this date the 29<sup>th</sup> of October 2021 between Personal Air Quality Systems, a Startup company developing solutions for environmental issues that impact health and wellbeing, situated at A 308, 2nd Floor, Block II, KSSIDC Building Electronics City, Bangalore 560100, INDIA (hereafter called "PAQS"), represented by its CEO, A. Valdhyanahan and The Kammavari Sangham Institute of Technology No. 14, Raghuvanahalli, Kanakapura Road, Bangalore-560109, Karnataka (hereafter called "KSIT"), an institute of higher education represented by its Principal and Director, Dr. Dilip Kumar K, states as follows:

Collaborations under this MoU are focused on; R&D in Data Gathering, Data Analysis and Processing, Developing Machine Learning models in the area of impact of air pollution on Health and wellbeing of humans; visiting faculty or R&D assignments, B.E. / M.Tech. / Ph.D. programs, short-term training, and short-term courses. This MoU is intended to expedite research and development of new methods and technologies that can be implemented in support of PAQS and KSIT's mission to support and participate in National Clean Air Programme (NCAP). It is also aimed at enhancing the quality of research and education at PAQS and KSIT.

Both PAQS and KSIT, believe that this Collaboration will contribute to more efficient resource utilization and accelerate methods and technology advancement in mutually agreeable areas of research. The two organizations further believe that successful collaboration will leverage beneficial results via method and technology transfer, education, and training.



**1.2. Objectives:** PAQS and KSIT will work collaboratively to expedite development of methods and technologies that are needed to address the scientific issues in the fields of interest of both the institutions.

**1.3. Goals:**

- i. Identify and formulate research and development projects that address issues in respect of fields of scientific interest and establish arrangements that describe how personnel and resources of PAQS and KSIT will be effectively utilized to perform research and development projects addressing the said issues.
- ii. Perform collaborative research and development projects in an expeditious manner.
- iii. Provide products from the research and development projects in a form and format that can be easily used and understood by the target group.
- iv. Collaborate in setting up Center of Excellence in IoT (Internet of Things) and education and training programs at PAQS or KSIT with resource persons from KSIT as well as PAQS. These may involve B.E. / M.Tech. / Ph.D. programs with guides and co-guides from the two organizations, continuing education for KSIT and other industry employees, short-term assignments at KSIT for PAQS (or at PAQS for KSIT) faculty or staff, etc.

**2. Background and Program Scope:**

**2.1. Background:** Air pollution is caused by a number of pollutants, which include both solid and liquid particles suspended in the air (particulate matter (PM)), and various gases such as ozone (O<sub>3</sub>), nitrogen oxides (NO<sub>2</sub> or NO<sub>x</sub>), volatile organic compounds (VOCs), and carbon monoxide (CO) etc. PM<sub>10</sub> Particulate Matter), is a priority pollutant internationally due to their adverse effects on public health as well as its negative effects on sensitive ecosystems, materials, and climate. PM<sub>2.5</sub> is responsible for a variety of health effects including effects on the respiratory and cardiovascular systems, asthma, and premature death. NO<sub>2</sub> can affect the respiratory system causing inflammation of the airways. People with asthma or respiratory diseases are particularly sensitive and can show effects at low concentrations. SO<sub>2</sub> causes constriction of the airways leading to breathing difficulties, particularly in those suffering from asthma and chronic lung disease. The main threat to human health from CO is the formation of carboxyhemoglobin in the blood, which substantially reduces the uptake and transport of oxygen in the body. VOCs can have a variety of health effects. Some species are directly toxic to humans and some produce offensive odors at very low concentrations.

NCAP has acted as a great impetus for the development of country's high technology industry that can be utilized to meet the health sector needs. However, acute shortage of skilled engineers, lack of relevant academic and research programs beyond the critical mass in the universities, and poor university-industry collaboration are hampering such development. Hence there is a pressing need for collaborative R&D in Air Pollution and clean air technologies among the Industry and Academia.

The PAQS is an Electronic Systems Design and Manufacturing company providing end-to-end, real-time, and actionable solutions to enable healthy living for every individual, community, and city. PAQS leverages a combination of technologies to provide Context Aware Solutions. The PAQS Engine is an inclusive IoT platform consisting of integrating outdoor, indoor, and personal devices, analytics, and a front-end mobile and web App, and employs IoT + LI + ML(Internet of Things, Location Intelligence & Machine Learning) for analytics and hyper-local data.

KSIT presently has oriented its research in the areas of Networking, IoT, Security, Image processing and Analytics in conjunction with Machine Learning algorithms. Among its faculties, It has a critical mass of world class researchers with unique capabilities and expertise in the above mentioned areas.

The KSIT CoE-IOT seeks collaborations with PAQS to achieve the following;

- Carrying research and developing algorithms enable calibrating general commodity class sensors to provide acceptable range of Air Quality parameters.
- Conduct a study on academic performance and identify its relationship and dependency on both indoor and outdoor air quality.
- Design and Develop prototypes catering to personal health especially for those impacted by poor air quality leading to breeding problems.

The center hence intends to foster a collaborative and cross disciplinary research in vigorous fashion in years to come.

**2.2. Program Scope:** Under this MoU the two organizations; PAQS and KSIT will identify areas of research and development, Prototyping, and patents in the fields of interest as indicated above, that can be efficiently addressed through a collaborative approach. R&D programs and the education and training programs will be carried out in PAQS, Bangalore and at KSIT Center for Excellence in IoT, KSIT Campus, Bangalore. The MoU is expected to lead the collaborative R&D efforts at either organization, through entrepreneurial incubation cells.

### 3. Responsibilities:

#### 3.1. PAQS agrees to

- i. Exchange information consistent with the objectives and mandate of PQS, and identify areas of collaboration. Develop, formulate, and submit proposals of interest singly or jointly with KSIT to DBT, DIT, DST, national laboratories (such as R&D projects, technology assessment, testing, calibration and consultancy), and carry out such sponsored projects, describe specific R&D projects, education activities and training programs jointly pursued by PAQS and KSIT.
- ii. Facilitate Ph.D. programs: Guide / Major Advisor shall be from PAQS or KSIT as required for the project and Co-guide shall be the other organization from PAQS for each such program.
- iii. Facilitate its Center for Research (laboratories, library, office support, fields, etc.) for conducting such research work.

- iv. Formulate and carry out continuing education programs / short-term courses for industry employees within PAQS domains of expertise.
- v. Make provisions for KSIT faculty as deputed / Visiting Faculty or Adjunct Professors, for research, training and teaching at KSIT for short durations.
- vi. Participate in joint technical activities (e.g., inspections, workgroups, scientific or engineering panels) with representatives from KSIT and other organizations which may be established to provide technical advice and guidance on issues related to the fields of interest of both the organizations.
- vii. Assign a Contact Point and Technical Lead for interactions with KSIT.
- viii. Jointly prepare annual summary report on the progress made under this MoU for each of the collaborations, or other cooperative activities, that are agreed as part of this agreement (MoU).
- ix. Record, produce and maintain minutes of meeting as described in this MoU in respect of meetings held at PAQS.

### 3.2. KSIT agrees to;

- i. Exchange information consistent with the objectives and mandate of KSIT and identify areas of collaboration. Develop, formulate, and submit proposals of interest singly or jointly with PAQS to DBT, DIT, DST, National Laboratories (such as R&D projects, technology assessment, testing, calibration and consultancy), and carry out such sponsored projects, describe specific R&D projects, education activities and training programs that will be jointly pursued by PAQS and KSIT.
- ii. Facilitate research training at KSIT for PAQS Staff / students in areas of interest to KSIT and relevant to the M.Tech. programs pursued by the students and make provisions (Center laboratories, library, workshop, office support, etc.) for such training.
- iii. Formulate and carry out continuing education programs / short-term courses for industry employees within KSIT domains of expertise. 50% concession in fees for such programs for PAQS employees shall be provided.
- iv. Take PAQS faculty on deputation to work in KSIT on-going projects so that the faculty member may gain further experience.
- v. Participate in joint technical activities (e.g., inspections, workgroups, scientific or engineering panels) with representatives from PAQS, to provide technical advice and guidance on-issues related to the fields of interest of both the organizations.
- vi. Assign a Contact Point and Technical Lead for interactions with the PAQS.
- vii. Jointly prepare annual summary report on the progress made under this MoU for each of the collaborations, or other cooperative activities, that are agreed as part of this agreement (MoU).
- viii. Record, produce and maintain minutes of meeting as described in this MoU in respect of meetings held at KSIT.

#### 4. Memorandum of Understanding (MoU) Administration:

- 4.1. **Reports:** The status of work performed under this MoU will be reviewed on an annual basis. The KSIT Contact Point will take the lead and be responsible for organizing meetings, developing agenda and recording results of the meetings. Minutes of the meetings will be produced by KSIT and be distributed to meeting participants as well as to the CEO of PAQS, and Principal of KSIT. A central file (retained by KSIT) will be maintained.
- 4.2. **Information Releases:** Principal KSIT and CEO PAQS will jointly review and approve information regarding MoU activities (meetings, new developments, etc.) prior to public release. Reports prepared under this agreement will stipulate specific procedures for the coordination, handling and public disclosure of information. All information disclosures concerning activities under this MoU or subsequent reports will comply with the guidelines of both the organizations governing the release of information. Where particular information protocols apply to a particular laboratory, or network of laboratories, those protocols will be followed by both parties to this MoU.
- 4.3. **Security Classification:** The highest security classification applied by both the parties will govern the handling of information and reports under this MoU, as appropriate. The security classification and procedures will be stipulated in each report.
- 4.4. **Facility Security, Health, Safety, and Environmental Compliance:** The host facility's security, health, safety, and environmental compliance programs will be followed by personnel when engaged in work activities as outlined in this MoU. Workers Injury Claims shall be covered by the employee's agency.
- 4.5. **Reimbursement Policy:** Each party to this agreement will handle and expend its own funds, except as otherwise noted in this MoU. The responsibilities assumed by each party are contingent upon funds being available from which expenditures legally may be met.
- 4.6. **Annual Management Meetings:** PAQS and KSIT will meet annually to plan and coordinate Collaboration under this MoU. Such meetings will be held at a mutually agreed upon location and on a date that is compatible with the planning and budgeting cycle of each organization. At this meeting, recommendations for adjustments to current activities, projects, and budget priorities will be proposed and agreed upon by the Contact Point for submission to the PAQS Director and Joint Registrar, KSIT for further action.
- 4.7. **Semi-Annual Technical Discussions:** PAQS and KSIT will meet at least twice a year to discuss technical progress under each project or activity. These reviews will require technical information exchange by PAQS and KSIT Technical Leads. These meetings may include individuals from outside of PAQS and KSIT as mutually agreed to by the respective Points of Contact.

**4.8. Technical Lead Responsibilities:** Technical Leads for each project or activity will strive to engage in:

- Providing technical information exchange consistent with agency regulations governing the exchange or release of information
- Delivering written or verbal technical evaluations of progress
- Conducting visit to sites where research is underway
- Organizing and participating in technical workshops and scientist-to-scientist meetings
- Reporting on any exceptional accomplishments from, or impediments to, successful program or project execution
- Recommending improvements for the MoU activities

**4.9. Approvals:** All plans and activities designed to carry out this MoU must be agreed to and approved by PAQS and KSIT prior to commencement of any technical work.

**4.10. Disclosure and use of Proprietary Information:** Both PAQS and KSIT recognize that successful Collaboration depends on full and prompt exchange of Proprietary information (Information not generated in the performance of this MoU and is proprietary to the disclosing party) necessary for carrying out this MoU. The nature and amount of Proprietary Information to be acquired by either party will be consistent with the objectives stated in Section 1.2 (Objective), Section 1.3 (Goals) of this MoU.

**Disclosure:** Each party, upon request, will disclose to the other party any relevant Proprietary Information provided that:

- a) Such Proprietary Information is necessary to or useful in the R&D purposes under this MoU and will be considered as confidential information and shall not be disclosed to any third party without the disclosing party's consent;
- b) Such Proprietary Information may be made available without incurring liability to holders of proprietary rights; and
- c) Disclosure is consistent with the rules and regulations of the disclosing party and other may use the Proprietary Information however, the disclosing party will retain all its rights with respect to such Proprietary Information.

**4.11. Inventions and Licensing:** Activities conducted under this MoU and any project or other extramural arrangements may result in products or processes that are patentable. The organization whose work results in the invention shall disclose the invention to the other organization and then prepare, file, and prosecute patent applications. If protection is granted, the inventing organization will manage the invention in accordance with its rules and regulations. To be clear, title to all inventions and discoveries made by PAQS resulting from the research performed hereunder shall reside in PAQS; title to all inventions and discoveries made by KSIT resulting from the research performed hereunder shall reside in KSIT; title to all inventions and discoveries made jointly by PAQS and KSIT resulting from the research performed hereunder shall reside jointly in PAQS and KSIT.

Both parties agree to grant to the other party an option to negotiate an exclusive, royalty-bearing license to make, use or sell any invention or discovery owned wholly or partly by PAOS or KSIT and made or conceived and reduced to practice during the term of this MoU which have directly resulted from the performance of the research hereunder. PAOS or KSIT shall notify the other party of its desire to enter into such a license agreement, and a license agreement shall be negotiated in good faith between the parties.

**5. Period of Agreement:**

- 5.1. This MoU shall be effective for 5 (Five) years from the date of the last signature unless cancelled in writing by either of the participating organization with 90 days' notice.

## **MEMORANDUM OF UNDERSTANDING**

THIS Memorandum of Understanding ("MOU") is signed between M/S Bizotic Edtech Pvt. Ltd. (hereinafter referred to as "Vendor"), with office at: 15, 3<sup>rd</sup> Main, 3<sup>rd</sup> Cross, Maruthi Nagar, J P Nagar 7th Phase, Bangalore – 560078.

And

K S Institute of Technology – (hereinafter referred to as "KSIT"), located at 14, Kanakapura Road, Raghuvanahalli, Bangalore – 560109.

WHEREAS, the Vendor is an established training company that has offered to provide training services to the students of KSIT; KSIT has accepted the training program as per the discussions.

NOW, THEREFORE, The Parties hereby accept and agree to conduct the training as per the following terms and conditions:

### **1. Objective**

The objective of the MoU is to outline the scope, policy and operating guidelines governing the aptitude and soft skills training of BE students to ensure its completion in a smooth and hassle-free manner in the best interests of the Vendor, the students and KSIT.

### **2. Scope**

- 2.1** This MOU shall not constitute, create, or give effect to a joint venture, partnership or a formal business organization of any kind between the two parties. Each party shall act as an independent contractor and not as an agent of the other, and neither shall have any authority to bind the other except to the extent specifically provided herein.
- 2.2** It is understood that this MOU purports to cover some of the major aspects of the training relationship between Vendor and KSIT. However, the headings and sub-headings of Clauses contained herein are used for convenience and ease of reference, but in no way define, limit or describe the spirit, scope or intent of this MOU or any of its provisions.
- 2.3** This MOU supersedes all prior proposals and discussions on this subject and is the complete and exclusive statement of the agreement between the parties. This MOU cannot be modified except by a written agreement signed by the authorized representative of each of

the parties. Any reproduction of this MOU by any reliable means will be considered as an original of this document.

2.4 If any provision/s of this MOU are found to be invalid or unenforceable, the validity or enforceability of the remaining provisions or portions hereof shall not be affected.

### **3. Training**

#### **3.1 Commencement**

The training will commence from the same week during which the MoU is signed, or on a date mutually agreed in writing between the Vendor and KSIT.

#### **3.2 Duration**

The duration of the training will be 30 hours per semester for 5<sup>th</sup> and 6<sup>th</sup> Semester BE students. The training will be delivered 6 hours per day for a total of 5 days in both 5<sup>th</sup> and 6<sup>th</sup> semester.

#### **3.3 Short fall in training hours**

If the number of hours available for training as per para 3.2 above falls short of the allocated hours; the shortfall would be made up by the vendor in consultation with KSIT.

#### **3.4 Program Content**

The contents of the training program for the students will be the aptitude topics relevant for BE students appearing for their placements

#### **3.5 Training Schedule**

The training schedule indicating the dates will be finalised by the vendor in consultation with KSIT. As such, the program for this semester will commence from August 2022.

### **4. Attendance of Students**

4.1 Attendance will be made mandatory by KSIT for all students undergoing training.

4.2 The attendance will be maintained by KSIT for all the students attending the training.

## **5. Students Feedback**

At the end of each session of training, Vendor will obtain a feedback from all the students on a point rating system and the same shall be made available to KSIT on demand.

## **6. Unscheduled Holiday**

If the college declares an unscheduled holiday due to any unforeseen circumstance/s, Vendor will be informed at the earliest, and the training hours lost on such account, would be suitably made good by the Vendor in consultation with KSIT.

## **7. Billing and Payment**

7.1 The price agreed upon by the vendor and KSIT is **Rs. 20 per hour per student Plus GST at 18%** per student for the 30 hour program.

7.2 A student will be considered for billing only if he/she attends a single day of training. If a student is not present even for a single session during the course of the training, then Bizotic will not raise a bill for such student.

7.3 50% of the payment would be done on 50% of completion of the training program. The full and final payment should be made within 10 days of completion of the program.

7.4 Payment will be made by a crossed cheque, payable to the Vendor or transferred through NEFT/RTGS to the bank account of the vendor.

## **8. Validity**

## 10. Termination/Extension


