- d) Three students, if the matter involves students, who shall be enrolled at the undergraduate, master's and research scholar levels respectively, elected/nominated through transparent
- e) One member from amongst non-government organizations or associations committed to the cause of women or a person familiar with the issues relating to sexual harassment, nominated



It was already informed vide the circular cited above, regarding constitution of College Internal Complaint Committee (CICC) at your College and inform the undersigned on or before 25th March 2022. However, as per the response received from few institutions following are the observations:

1. Principal, Vice-Principal is the chairperson of CICC.

2. One-half of the total members of the CICC are Male members as compare to women in the committee.

3. Failed to send undersigned acceptance letters of all the members of CICC.

4. Some of the colleges failed to constitute the CICC and send the details.

5. Some of the colleges have not sent the CICC formation details from the respective region.

If committee is not constituted till now, kindly constitute the committee as per the composition / UGC Regulations 2015, and inform as well as send the details of the members of the committee and the acceptance letters of each member by e-mail to vtuice@vtu.ac.in on or before 06-10-2022, 4:00 p.m to this office and hard copy by post.

Composition of CICC shall be:

- a) A Chairman should be a woman faculty member employed at a senior level, not below the rank of Associate Professor.
- b) Two faculty members and two non-teaching employees, preferably who have had experience in social work / have legal knowledge / work for the development of woman.
- c) Three students, if the matter involves students, who shall be enrolled at the undergraduate, master's and research scholar levels respectively, elected through transparent democratic procedure.
- d) One member from amongst non-government organization. (A person familiar with the issues relating to sexual harassment).
- e) At-least one-half of the total members of the CICC shall be women.
- f) Principal / Director should not be a part of the committee.
